“Healthy Youth Act” (AB 458, 2009) Mandates that every school district choosing to provide a sex ed program must implement a comprehensive sex education curriculum. Among other provisions, the bill removed the existing requirement that abstinence be taught as the preferred method for avoiding teenage pregnancy and sexually transmitted infections.	No	Yes
“Concealed Carry” (SB 93, 2011) Permits individuals to carry a concealed weapon, with certain training and licensing requirements and certain restrictions on where such a weapon can be carried.	Yes	Yes
“Voter ID” (AB 7, 2011) Among other changes, requires citizens voting at the polls or by absentee ballot to show a photo ID and requires poll workers to verify the address of voters.	Yes	No
State Budget (AB 75, 2009) Biennium budget increased taxes by over \$2 billion, increased borrowing to \$3.58 billion, and had a structural deficit of \$2.33 billion.	No	Yes
State Budget (AB 40, 2011) 2011-2013 state budget disallows funding for organizations that provide or refer for abortions, or are associated with organizations that do; prohibits the use of tax dollars by the UW Hospital and Clinics Authority to subsidize abortions in any way; does not increase taxes and eliminates structural deficit.	Yes	No
